

# **PRIVACY STATEMENT**

M & S Contractors (Fife) Ltd ("We") are committed to protecting and respecting your privacy.

This policy sets out the basis on which any personal data we collect from you, or that you provide to us, will be processed by us. Please read the following carefully to understand our views and practices regarding your personal data and how we will treat it. For the purpose of the Data Protection Act 1998 (the Act), the data controller is M & S Contractors (Fife) Ltd, 2 Fernlea Drive, Windygates, KY8 5FB.

## Information we may collect from you

We may collect and process the following data about you:

- Information you give us. You may give us information about you by filling in
  forms on our site or by corresponding with us by phone, e-mail or
  otherwise. This includes information you provide when you register to use
  our site, subscribe to our service, search for a product and when you report
  a problem with our site. The information you give us may include your
  name, address, e-mail address and phone number.
- Information we collect about you. With regard to each of your visits to our site we may automatically collect the following information:

- Technical information, including the Internet protocol (IP) address used to connect your computer to the Internet, your login information, browser type and version, time zone setting, browser plug-in types and versions, operating system and platform;
- Information about your visit, including the full Uniform Resource Locators
  (URL) clickstream to, through and from our site (including date and time);
  products you viewed or searched for; page response times, download
  errors, length of visits to certain pages, page interaction information (such
  as scrolling, clicks, and mouse-overs), and methods used to browse away
  from the page and any phone number used to call our customer service
  number.
- Information we receive from other sources. We may receive information about you if you use any of the other websites we operate or the other services we provide. In this case we will have informed you when we collected that data that it may be shared internally and combined with data collected on this site. We are also working closely with third parties (including, for example, business partners, analytics providers, search information providers) and may receive information about you from them.

#### Cookies

#### Uses made of the information

We use information held about you in the following ways:

Information you give to us. We will use this information:

- to carry out our obligations arising from any contracts entered into between you and us and to provide you with the information, products and services that you request from us;

- to provide you, with information about goods or services we feel may interest you. If you are a new customer. If you do not want us to use your data in this way, for marketing purposes, please tick the relevant box situated on the form on which we collect your data;
- to notify you about changes to our service;
- to ensure that content from our site is presented in the most effective manner for you and for your computer.

We may use the services of third party data processors such as printers or marketing agencies when providing you with information about our goods and services and in contacting you to participate in marketing surveys.

Information we collect about you.

#### We will use this information:

- to improve our site to ensure that content is presented in the most effective manner for you and for your computer;

- to allow you to participate in interactive features of our service, when you choose to do so;
- as part of our efforts to keep our site safe and secure;

Information we receive from other sources.

We may combine this information with information you give to us and information we collect about you. We may us this information and the combined information for the purposes set out above (depending on the types of information we receive).

## Disclosure of your information

- If M & S Contractors (Fife) Ltd or substantially all of its assets are acquired by a third party, in which case personal data held by it about its customers will be one of the transferred assets.
- If we are under a duty to disclose or share your personal data in order to comply with any legal obligation, or in order to enforce or apply our terms of use and other agreements; or to protect the rights, property, or safety of M & S Contractors (Fife) Ltd our customers, or others. This includes exchanging information with other companies and organisations for the purposes of fraud protection and credit risk reduction.

## Where we store your personal data

The data that we collect from you may be transferred to, and stored at, a destination within the European Economic Area ("EEA"). By submitting your

personal data, you agree to this transfer, storing or processing. We will take all steps reasonably necessary to ensure that your data is treated securely and in accordance with this privacy policy.

All information you provide to us is stored on our secure servers. Where we have given you (or where you have chosen) a password which enables you to access certain parts of our site, you are responsible for keeping this password confidential. We ask you not to share a password with anyone.

Unfortunately, the transmission of information via the internet is not completely secure. S-FID - Adobe Analytics - This cookie is used by Adobe Analytics to help measure the amount of traffic on our website.
